## The Art, History & Palaces of Vienna & The Danube Valley

### 5 days from £1,299 Departs 15th June 2025

### Day 1

We meet at our designated pick up points and transfer by private coach to either Heathrow or Stansted Airport for our direct scheduled flight to Vienna. On arrival in Vienna we are met by our guide and transfer in our private executive coach to the 4\* Renaissance Hotel for a four night stay. We enjoy an included dinner in our hotel this evening.

### Day 2

Our morning guided city tour of Vienna takes in the imperial and architectural beauty of the city, a reminder of the great wealth of the Hapsburgs and the splendour of the Austro-Hungarian Empire. During our guided tour we visit Karlskirche, dedicated to St Karl Borromeo. Designed by Johann Fischer von Erlach, a famous Austrian Baroque architect, the building of Karlskirche commenced in 1715 and is the largest Baroque cathedral north of the Alps. Our guided tour also includes a visit to St Stephen's Cathedral, dating back to 1147 and for a long time uncontested as the tallest building in Europe. This afternoon we visit Schönbrunn Palace, commissioned in 1696 by Leopold I, completed in 1730, and adapted in the mid 18th century for Maria Theresa. Our guided tour will include her bedroom, hung with Brussels tapestries, her breakfast room decorated with needlework worked by her and her daughters, and the Hall of Mirrors, where Mozart, aged 6, gave his first recital. The gardens were laid out with fountains and statues, and later, on the Gloriette Hill, a colonnaded arcade was added, from which one has an extensive view over the city.

### Day 3

Today we explore the UNESCO listed Danube Valley with its rich history and magical scenery. Our first stop is for a guided tour of Baroque Melk Abbey, which towers above the Danube on a promontory. Begun as a palace stronghold in the 10th century and given to Benedictine monks in the 12th century, the interior is lavishly gilded, has ceiling frescoes and superb sculpted pulpit, choir and confessionals. We have time for lunch in Melk, a pretty town with Renaissance buildings, before embarking on an included cruise along the scenic Danube to Krems, the area centre of the wine industry, with its mixture of historical buildings and a Renaissance town hall.

### Day 4

We visit the Albertina this morning for a guided tour, a grand Viennese palace that has recently been made the home of a permanent exhibition tracing the progression from Impressionism to Modernism. The artists range from the French masters Monet, Degas and Cézanne, to Picasso and the abstract expressionists, Mark Rothko and Sam Francis. This afternoon we enjoy a guided tour at the Kunsthistorisches Museum. In the mid-19th century Franz Joseph commissioned magnificent buildings to be erected along the new circular boulevard, the Ringstrasse, amongst which was the Kunsthistorisches Museum, built to house the Imperial Collections. In this huge and sumptuously decorated building are to be found paintings, mainly the Old Masters from the 15th to the 18th centuries, antiquities, including those of early civilisations, sculptures and decorative arts, coins and medals, and numerous other artefacts. This evening there is an optional excursion to the Strauss and Mozart concert at the Kursalon in Vienna. From the very place where Johann Strauss used to direct his orchestra, the evening offers the memorable sound of waltzes, polkas, arias and duets, as well as operetta and piano concerto melodies.

### Day 5

We visit Upper Belvedere Palace this morning, and our guided tour on arrival introduces us to a fine collection of Austrian art dating from the Middle Ages to the present day, including the world's largest Gustav Klimt collection. We transfer to Vienna Airport for our direct scheduled flight to either Heathrow or Stansted Airport, and onwards private coach travel back to our original pick up points.

NB:- Please note we reserve the right to alter the above itinerary if required for operational reasons. Given the historic nature of the places visited, a certain degree of walking will be involved, and this holiday may not be suitable for those with mobility problems.

It is important that you read the following conditions together with additional general information contained within the brochure for your holiday. In these Booking Conditions, "we", "us" and "our" are Tailored Travel Limited.

### 1. HOLIDAY PAYMENT

We expect to confirm your booking within 10 days of receiving your booking form and deposit or full booking within 10 days of reeewing your booking form and opposit or payment as applicable. You must check your confirmation invoice, tickets and all other documents you receive from us carefully as soon as your receive from. Please contact us immediately if any Information on any document appears to be incorrect as it may not be possible to make changes later. We reger the cannot accept any liability if we are not notified of any inaccuracy in any document within 5 days of our

### 3. HOLIDAY CANCELLATION BY YOU

If you have to cancel your holiday you must do so in writing. The cancellation charges you incur depend on when we receive this written notification and are as follows:

Should you wish to make any changes to your holiday, please advise us as soon as possible in writing. We will endeavour to meet requests if we can. ### 5. ALTERATIONS AND CANCELLATIONS BY US

Occasionally, we have to make changes to and correct errors in the brochure or booklets supplied and other details both before and after procurie or powers supplied and other details dome before and after bookings have been confirmed and cancel confirmed bookings. Whilst we always endeavour to avoid changes and cancellations, we must reserve the right to do so. Most changes are minor. Minor changes do not entitle you to cancel or change to another holiday without paying our normal charges.
